# 2025 Beat the Host Official Rules

#### The Tournament:

Beat the Host Online Handicapping Tournament is a competition in which any competitor whose total mutuel payoffs exceeds the host's total mutuel payoffs in any of eight (8) weekly qualifying competitions (cited below) will earn a seat in the Beat the Host Championship to be held on Saturday, March 8, 2025. The top three (3) finishers each week will receive a total of \$2,000 in prizes. The top five (5) players who cumulatively earn the most money throughout the entire 8 week tournament will earn a seat to either the 2026 Pegasus World Cup Betting Championship (two (2) seats total to be awarded) or the 2025 1/ST Ultimate Betting Challenge (three (3) seats total to be awarded). The top seven (7) finishers in Beat the Host Championship will receive prizes. The top finisher will earn one (1) seat in the 2026 Pegasus World Cup Betting Championship. The next six (6) finishers will earn a \$1,500 Xpressbet contest credit to be used towards an online entry into either the \$1,500 Xpressbet Florida Derby Challenge (March 29, 2025) or the \$1,500 Xpressbet Santa Anita Derby Challenge (April 5, 2025). Additionally, a \$6,500 Sweep the Host Bonus will be awarded to any single player who exceeds the host's cumulative mutuel total in each of all eight (8) weeks of the qualifying-round. If no player wins the Sweep the Host Bonus, a \$4,000 consolation prize will be awarded to the player who is the last to lose to the host in weekly competition. If two or more such players are the last to lose to the host, they will divide the prize equally.

Players must register for the competition online at www.xpressbet.com. There are no entry or registration fees. Players need to register only once to be eligible to compete in all subsequent weeks.

Each time they play, competitors make a single, online, 'live' \$5 Win wager on one (1) horse in each of up to ten (10) competition races—a total of up to \$50 in 'live' competition wagers. Player accounts will be credited with winnings for all competition wagers and debited for all losing wagers.

Certain jurisdictions may have withholdings that potentially would affect a player's pari-mutuel payout. For Tournament participants in these jurisdictions, the payouts for their Contest Wager(s) will reflect the actual payout they receive and will not be adjusted to match the payouts received by participants in jurisdictions that do not levy withholdings on winnings.

Track and competition race information will be available online at www.xpressbet.com each Friday by 5:00PM ET. Host picks will be announced on a race by race basis, as each competition race goes off.

Only online wagers on the selected tracks and races submitted on the Contest Wager Pad or Mobile Wager Pad are eligible for competition. Wagers placed using the traditional Non-Contest Wager Pad or Wagers placed by telephone, do not qualify.

Players may compete each week in the Qualifying Round but may win only one seat in the Championship Round. They may earn multiple prizes in the Qualifying Round.

Players must exceed the host's cumulative mutuel payoff total in at least one (1) of eight (8) weekly handicapping competitions in order to qualify for the Championship Round of the Tournament ("Championship Round").

For Tournament scoring purposes in both Beat the Host Qualifying and Championship Rounds, mutuel payoffs on winning selections will be capped at 20-1 (\$105).

Any player who beats the host in a weekly competition will earn one (1) seat in the Championship Round. If no player exceeds the host's total in any weekly competition, no one will earn seats in the Championship Round and no prizes will be awarded.

Competitors in the Championship Round must make a single, online \$5 'live' Win wager on one (1) horse in each of the ten (10) competition races (\$50 total). Track and race information for wagering in the Championship Round will be available online Friday, March 7, 2025 by 5:00PM ET.

## To Enter:

Participants must register for the Tournament by following instructions on <u>www.xpressbet.com</u>. Participants must have an account in good standing. One (1) account per person. One (1) registration per person.

# To Play:

Registered entrants must place a single \$5 'live' Win wager online, on one (1) horse in up to ten (10) competition races. Weekly competition races will be announced on <u>www.xpressbet.com</u> each Friday by 5:00PM ET. Host picks will be revealed on a race-by-race basis, as each competition race goes off. Players will not be able to see the host pick prior to the competition race. Entrants are not required to wager on all ten (10) competition races in order to participate or to qualify for the Championship Round. Registered entrants must use their online wagering accounts to place wagers in order for the wagers to be eligible. Wagering must be submitted via the Special Contest Wager Pad or via the Mobile Contest Wager Pad to be eligible. Wagers placed using the traditional Non-Contest Wager Pad or by telephone do not qualify.

Wagers on scratched horses earn zero in the competition. If a player notices that his horse is scratched in a particular race he may submit a \$5 Win wager on another horse in that race before wagering closes for that particular race. The player must use the Special Contest Wager Pad to submit all tournament plays including replacement plays for scratched horses. Once a late scratch is processed by tote, the Special Contest Wager Pad will be available for submission of replacement wagers on scratched horses.

In the Championship Round (March 8, 2025) qualifiers must place a single, \$5 'live' Win wager online, on one (1) horse in each of ten (10) competition races identified on the web site beginning on Friday, March 7, 2025. Entrants must use their online wagering accounts and place wagers by using the Special Contest Wager Pad or Mobile Contest Wagering Pad for the wagers to be eligible. Wagers placed using the traditional Non-Contest Wager Pad or Wagers placed by telephone, do not qualify.

Entries must be made in accordance with these Official Rules; any other attempted form of entry will NOT be accepted. Any use of robotic, automatic, macro, programmed or like call-in or registration entry or wager methods will void all such entries by such methods, and result in disqualification of any entrant using such methods.

Participants are only eligible to win one (1) placement in the Championship Round but can win multiple prizes during the Qualifying Round.

### **Qualifying Round Dates:**

Results for each round will be posted and winners notified by 5:00PM ET each Monday following the Qualifying Round date. Prizes will be awarded as soon as winner qualification is verified.

#### **Championship Round Date:**

Saturday, March 8, 2025

Results for the Championship Round will be posted and winners notified by 5:00PM ET Monday, March 10, 2025. Prizes will be awarded as soon as winner qualification is verified.

#### **Qualifying Round & Championship Round - Provision for Canceled Races**

- If races at either Gulfstream Park or Santa Anita Park are canceled, contest races will be the final 10 live races at Gulfstream Park or the first 10 races at Santa Anita Park.
- If Gulfstream Park or Santa Anita Park cancels, and the remaining track does not have a card of 10 or more races, all races at the remaining track will be offered and the tournament will be considered full following the contest. For example, if Santa Anita Park cancels and Gulfstream Park has a 9-race card, the tournament will consist of all 9 races from Gulfstream Park.
- If both tracks cancel racing, tournament officials reserve the right to substitute another track (or tracks) or cancel that day's tournament.
- In the event that Gulfstream Park or Santa Anita Park cancels, and contest officials believe that players have not been given ample time to modify their wagers and approach, that week's contest will be canceled.
- Any updates regarding cancelations will be posted to Xpressbet.com in a timely manner.

### To Win:

The winner of the Tournament will be selected from wagers placed by eligible registrations received during the Tournament period. Winner(s) will be determined solely based upon the total winnings of the ten (10) eligible wagers. Winner(s) will be determined by Xpressbet, LLC Management, whose decisions are final and binding in all respects.

Prizes may not be substituted, transferred or assigned by participants.

### Prizes/Odds of Winning:

## Qualifying Rounds (January 4, 11, 18, 25 and February 1, 8, 15, 22)

Prizes for each weekly Saturday competition, will be announced on the following Monday, and will be posted at participating web sites by 5:00PM ET. Prizes for each weekly Qualifying Round are:

**1st:** \$1,000 **2nd Prize:** \$750 **3rd Prize:** \$250

Prizes will be in the form of wagering credits deposited to the winner's Xpressbet wagering account. Wagering credits may only be withdrawn from an account in accordance with Xpressbet's policies, which can be found at https://www.xpressbet.com/terms.

Qualifying round prizes are not transferable.

Odds of winning are determined by number of eligible entries received for the Tournament.

### **Qualifying Rounds Tie-Breaking Procedures**

In the event of a tie for any wagering credit prize position between players the prize for the next highest position will be combined with that of the tied position and the total will be evenly divided among all tied players.

### Sweep the Host Bonus

Players who beat the host in all eight (8) weekly Qualifying Rounds are eligible for an additional Sweep the Host Bonus prize. If one (1) player beats the host in all eight (8) weeks, that player will receive \$6,500. If two (2) or more players beat the host's total in all eight (8) weeks, the Bonus prize will be divided between them equally. If no player beats the host in all eight (8) weeks, a \$4,000 Consolation prize will be awarded to the last of those players to lose to the host in a weekly competition. If two or more such players are the last to lose to the host, they will divide the prize equally.

Sweep the Host Bonus will be in the form of wagering credits deposited to the winner's Xpressbet wagering account. Wagering credits may only be withdrawn from an account in accordance with Xpressbet's policies.

Sweep the Host bonus prizes are not transferable.

Odds of winning are determined by number of qualified participants in the tournament.

### Seasonal Prizes (January 4, 2025 through February 22, 2205)

Players who cumulatively earn the most money throughout the eight (8) Qualifying Rounds of the 2025 Beat the Host competition will have their choice of the following:

- Two (2) entries into the 2026 Pegasus World Cup Betting Championship (PWCBC). Entries are valued at \$6,000 each and must be played online at Xpressbet.
- Three (3) entries into the 2025 1/ST Ultimate Betting Challenge (held March 1, 2025). Entries are valued at 6,000 each and must be played online at Xpressbet.

Seasonal prizes are not transferable.

Odds of winning are determined by number of qualified participants in the tournament.

## Seasonal Prizes Tie-Breaking Procedure (January 4, 2025 through February 22, 2205)

In the event of a at the end of the qualifying round for determining the Seasonal Prize winners the following tie-breakers will be used:

First Tie-Breaker – The player with the single highest winning mutuel payoff of all tied players will be ranked above the others. If a tie still remains, the player with the second-highest single mutuel payoff of all tied players will be ranked above the others. This process will continue until the tie is broken.

Final Tie Breaker – If two (2) or more players remain tied after the first tie-breaker procedure has been exhausted, the final tie breaker will go to the player who chronologically is first to register for the Beat the Host tournament.

All decisions are final.

# Championship Round (March 8, 2025)

Prizes will be awarded for the Championship Round, and will be posted at participating web sites by 5:00PM ET on Monday, March 10, 2025. Prizes for this Round are:

- One (1) entry into the 2026 Pegasus World Cup Championship Betting Challenge (PWCBC). Entries are valued at \$6,000 each and must be played online at Xpressbet.
- Six (6) \$1,500 in Xpressbet contest credits that can be used as buy-in for either the \$1,500 Xpressbet Florida Derby Challenge (March 29, 2025) or the \$1,500 Xpressbet Santa Anita Derby Challenge (April 5, 2025). Entries are valued at \$1,500 each and must be played online at Xpressbet.

Championship prizes are not transferable.

Odds of winning are determined by number of qualified participants in the Championship Round.

# Championship Round Tie-Breaking Procedure (March 8, 2025)

In the event of a tie in the Championship Round the following tie-breakers will be used:

First Tie-Breaker – The player with the single highest winning mutuel payoff of all tied players will be ranked above the others. If a tie still remains, the player with the second-highest single mutuel payoff of all tied players will be ranked above the others. This process will continue until the tie is broken.

Final Tie Breaker – If two (2) or more players remain tied after the first tie-breaker procedure has been exhausted, the final tie breaker will go to the player who chronologically is first to register for the Beat the Host tournament.

All decisions are final.

## Legal and Eligibility:

Beat the Host Online Handicapping Tournament ("Tournament") is offered only in the United States (where legal) and is open only to legal U.S. residents (of such jurisdictions where Tournament is lawfully offered), 18 years of age (21 in some states) or older as of January 4, 2025. # To Establish an Xpressbet Account:

Xpressbet applications are accepted online at www.xpressbet.com; by calling toll-free (866) 889-7737; or in-person at an Xpressbet center at any one of the following race tracks: Hawthorne Race Course (Cicero, IL), Laurel Park (Baltimore, MD), Pimlico Race Course (Baltimore, MD), Santa Anita Park (Arcadia, CA), The Meadows (Meadowlands, PA) and Thistledown (Cleveland, OH). Follow all instructions, first providing your name, complete residential address (including zip code), telephone number, date of birth, social security number, driver's license number and state, email address and mailing address (if different from residential address). You will also be asked if you wish to receive email updates about Xpressbet, LLC.; you may complete and submit the application (and register for the Tournament) without consenting to receive such email updates. If submitting application online, indicate your preference by either retaining or removing the checkmark from the designated box. Then, select a username and password, security question and answer, and PIN and account password for your Xpressbet account. Upon completion of these steps, and valid identity check, you will be assigned a unique Xpressbet account number. As part of the application procedure, you may then also activate your Xpressbet account for wagering by depositing funds into the account. Once the application procedure has been completed and your Xpressbet account has been established, you may register for the Tournament by following instructions located on the home page of the Xpressbet web site located at www.xpressbet.com.

## Taxes:
