### 2024 Fun in the Sun Tournament

# **Official Rules**

#### The Tournament

Horse racing's hottest summer tournament, Fun in the Sun, challenges players to handicap the best races at Saratoga and Del Mar on Saturdays beginning July 20, 2024, to win weekly and seasonal cash prizes. Each weekly contest requires a \$25 Entry Fee and \$100 Bankroll and the Top 3 finishers receive cash prizes. The top five finishers each week qualify for the 'Final Table,' where the prize pool has been seeded with a \$10,000 contribution from 1/ST BET and Xpressbet.

#### **Dates**

A separate weekly tournament is held every Saturday in July and August that Del Mar and Saratoga are both scheduled to race:

- Saturday, July 20
- Saturday, July 27
- Saturday, August 3
- Saturday, August 10
- Saturday, August 17
- Saturday, August 24
- Saturday, August 31

### **Final Table**

Monday, September 2

#### Buy-In

- Each Weekly Tournament requires a \$25 Entry Fee, withdrawn at the time of registration, and an additional \$100 Bankroll. The total cost to play each Saturday is just \$125.
- You must have a 1/ST account balance of at least \$25 to register for this tournament.
- Players may purchase up to two (2) entries each week.
- You must register for each weekly tournament. Registration for each weekly tournament begins the preceding Wednesday at approximately 3:00PM ET.
- Registrations will close each week at the start of the first tournament race.

# **How To Play – Weekly Tournament**

- \$10 Win Bets on the ten (10) tournament races:
  - Final Five (5) races at Saratoga
  - o First Five (5) races at Del Mar
- No other bet types or bets are allowed.
- Registrants may only bet one horse in each tournament race.

- Leaderboard is ranked according to total mutuel payoffs and prizes are awarded to the highest ranked players following the ten (10) tournament races.
- All tournament wagers must be made using the Contest Wager Pad.
- Players may cancel a tournament wager for any reason. Once a tournament wager is canceled, the player may make another tournament wager on that race.
- Should an entry in a contest fail to meet the above-mentioned requirements, that entry shall be disqualified from the contest, making the entry ineligible to win prizes. Any situation involving a late scratch where it is deemed the players were not given sufficient time to adjust their betting will be handled on a case-by-case basis by contest officials.

# **Weekly Prizes**

- 70% of Entry Fees are Paid out each week ("Weekly Prize Pool") with an additional 30% carried over to the Fun in the Sun 'Final Table' on Monday, September 2, 2024 ("Seasonal Prize Pool").
- Weekly Prize Breakdowns:
  - o 1st Place Finisher: 60% of Weekly Prize Pool + Final Table Seat
  - o 2nd Place Finisher: 25% of Weekly Prize Pool + Final Table Seat
  - o 3rd Place Finisher: 15% of Weekly Prize Pool + Final Table Seat
  - o 4th Place Finisher: Final Table Seat
  - 5th Place Finisher: Final Table Seat
- The top five (5) finishers each week qualify for the \$10,000-added Fun in the Sun 'Final Table' on Monday, September 2, 2024.
- Players may qualify for the Final Table a maximum of two (2) times.

Weekly Cash Prizes will be in the form of wagering credits deposited to the winners 1/ST wagering account. Wagering credits may only be withdrawn from an account in accordance with 1/ST's policies.

#### **Ties for Weekly Prizes**

- Tiebreaker for 'Final Table' Seats: Tiebreakers for Final Table seats will be broken in the following manner:
  - Tiebreaker #1) The person who placed the most winning bets will be ranked atop all tied players.
  - Tiebreaker #2) The player who chronologically registered for the tournament first is ranked atop tied players.
- Tiebreaker for Cash Prizes: The cash prize for that position, plus the cash prize for the next lowest position, will be combined and divided equally between tied players.

# **Weekly Tournament – Sample Prize Structure**

- Based on 150 entries per week at a \$25 entry fee.
- Weekly Cash Prize Pool: \$2,625 (150 x \$25 x 70%)
- Weekly Carryover to Final Table: \$1,125 (150 x \$25 x 30%)
- Weekly Prize Payouts:

1st Place Finisher: \$1,575 (60% of Weekly Prize Pool) + Final Table Seat
 2nd Place Finisher: \$656.25 (25% of Weekly Prize Pool) + Final Table Seat
 3rd Place Finisher: \$393.75 (15% of Weekly Prize Pool) + Final Table Seat

4th Place Finisher: Final Table Seat5th Place Finisher: Final Table Seat

# **Weekly Tournament – Provision for Canceled Races**

- If races at either Saratoga or Del Mar are canceled, the contest races will be the final 10 races at Saratoga or the first 10 races at Del Mar.
- If Saratoga or Del Mar cancels and the other track does not have card of 10 or more races, all races as the remaining track will be offered and the tournament will be considered full following the contest. For example, if Saratoga cancels and Del Mar has a 9 race card, the tournament will consist of all 9 races from Del Mar.
- If both tracks cancel racing, tournament officials reserve the right to substitute another track or cancel that day's tournament.
- In the event that Saratoga or Del Mar cancels and contest officials believe that players have not been given ample time to modify their wagers and approach, that week's contest will be canceled and all entry fees will be returned to registered players.

### \$10,000-added Fun in the Sun 'Final Table'

- Contested Monday, September 2, 2024
- Buy-In
  - There is no Buy-In for the Final Table. The only way to qualify for the Final Table is to finish 1st through 5th in any Weekly Tournament.
  - o 1/ST will pay the \$100 Bankroll for all Final Table qualifiers.

### **How to Play – Final Table**

- \$10 Win Bets on the ten (10) tournament races:
  - Final Five (5) races at Saratoga (TB)
  - o First Five (5) races at Del Mar
- No other bet types or bets are allowed.
- Registrants may only bet one horse in each tournament race.
- Leaderboard is ranked according to total mutuel payoffs and prizes are awarded to the highest ranked players following the ten (10) tournament races.
- Should an entry in a contest fail to meet the above-mentioned requirements, that entry shall be
  disqualified from the contest, making the entry ineligible to win prizes. Any situation involving a
  late scratch where it is deemed the players were not given sufficient time to adjust their betting
  will be handled on a case-by-case basis by contest officials.

### 'Final Table' Prizes

- The Final Table Prize Pool consists of a \$10,000 seeded contribution from 1/ST and all Seasonal Prize Pools collected each week (30% of weekly entry fees).
- Final Table Prize Breakdown:

1st Place Finisher: 55% of Final Table Prize Pool

o 2nd Place Finisher: 25% of Final Table Prize Pool

o 3rd Place Finisher: 10% of Final Table Prize Pool

o 4th Place Finisher: 5% of Final Table Prize Pool

o 5th Place Finisher: 5% of Final Table Prize Pool

Prizes will be in the form of wagering credits deposited to the winners 1/ST wagering account. Wagering credits may only be withdrawn from an account in accordance with 1/ST's policies.

### Final Table - Provision for Canceled Races

• In the event of a Final Table track cancelation, Saturday, September 7, 2024 will be used as a 'make-up' date for the Final Table event and the tournament will consist of the first ten (10) races at Del Mar.

Mutuel payoffs are capped at 20/1 (\$210) for contest scoring purposes.

All Decisions are final.

Prizes may not be substituted, transferred or assigned by participants.

Prize winners will be posted at www.xpressbet.com by 5:00pm Eastern Time each Monday following a competition Saturday.

Prizes will be awarded as soon as winner qualification is verified.

# **Legal and Eligibility**

Xpressbet's 2024 Fun in the Sun Saratoga/Del Mar Tournament ("Tournament") is offered only in the United States (where legal) and is open only to legal U.S. residents (of such jurisdictions where

Tournament is lawfully offered), 18 years of age (21 in Alabama, Arizona, Kansas, Indiana, Iowa, North Dakota, New Hampshire and Washington) or older as of the date of each of the weekly competitions. Residents of Washington and Michigan are not eligible to participate in this tournament. Employees, officers and directors (and their immediate families [parents, children, spouses and siblings] regardless of where they live and members of their same households [whether related or not]) of Xpressbet, LLC its parent, subsidiaries, affiliates and agencies; and entities engaged in the development, distribution, implementation or administration of the Tournament are not eligible to enter. Failure to disclose any ownership interest or license can result in disqualification.

### To Establish an Xpressbet Account

Xpressbet applications are accepted online at www.xpressbet.com; by calling toll-free (866) 889-7737; or in-person at an Xpressbet center at any one of the following race tracks or wagering facilities: Gulfstream Park (Hallandale Beach, FL), Laurel Park (Baltimore, MD), Pimlico Race Course (Baltimore, MD), Santa Anita Park (Arcadia, CA), Canterbury Park (Shakopee, MN), Suffolk Downs (East Boston, MA), The Meadows (Meadowlands, PA), Hawthorne Race Course (Cicero, IL), Club Hawthorne OTBs (various locations) and Thistledown (Cleveland, OH). Locations are subject to be added or removed, so please contact Xpressbet Customer Service at (866) 889-7737 for the most current list. Follow all instructions, first providing your name, complete residential address (including zip code), telephone number, date of birth, social security number, driver's license number and state, email address and mailing address (if different from residential address). You will also be asked if you wish to receive email updates about Xpressbet, LLC; you may complete and submit the application (and register for the Tournament) without consenting to receive such email updates. If submitting application online, indicate your preference by either retaining or removing the checkmark from the designated box. Then, select a username and password, security question and answer, and PIN and account password for your Xpressbet account. Upon completion of these steps, and valid identity check, you will be assigned a unique Xpressbet account number. As part of the application procedure, you may then also activate your Xpressbet account for wagering by depositing funds into the account. The Privacy Policy and Terms and Conditions of Use may be found at www.xpressbet.com by clicking on the appropriate links on the home page and certain other pages of the web site.

Once the application procedure has been completed and your Xpressbet account has been established, you may register for the Tournament by following instructions located on the homepage of the Xpressbet web site located at <a href="https://www.xpressbet.com">www.xpressbet.com</a>.

### **Selecting Winner**

The winner of each weekly Tournament will be selected from wagers placed by eligible registrations received during the Tournament period. Winner(s) will be determined solely based upon mutuel payoffs actually paid to the player based on \$10 'live' Win contest wagers each Saturday in 10 competition races. Winner (s) will be determined by Xpressbet, LLC management, whose decisions are final and binding in all respects.

The winner of the Final Table will be selected from wagers placed by eligible participants during the Final Table competition. Winner(s) will be determined solely based upon the combined earnings (highest mutuel payoff actually paid to the player) of the \$10 'live' Win contest wagers submitted on the select tournament races. Winner(s) will be determined by Xpressbet, LLC management, whose decisions are final and binding in all respects.

Prizes may not be substituted, transferred or assigned by participants.

All decisions are final.

#### Taxes

Liability for any and all federal, state and local taxes rests solely with the prize winner.

#### **Notification of Winners**

Names of winners will be posted to the xpressbet.com web site and winners will be notified within one week of competition. Winners will be notified via one of the following: e-mail, US postal mail or telephone.

# Prizes/Odds of Winning

Odds of winning are determined by number of eligible entries received for the Tournament. Cash Prizes will be in the form of wagering credits deposited to the winners Xpressbet wagering account. Wagering credits may only be withdrawn from an account in accordance with Xpressbet policies.

#### **General Conditions**

In order to be eligible to receive a prize, the Prize Winner is obligated, and by entering, agrees to execute an Affidavit of Eligibility, General Release of Liability, Indemnity and Publicity Consent (where legal), which is to be returned to Xpressbet within the indicated time period.
